### **Promotions Terms & Conditions**

### **Welcome Bonus**

- 1. The Welcome Bonus is only available for new clients that have not previously held an account
- 2. The Welcome Gift promotion is available only on the Classic account
- 3. The percentage of welcome bonus is available on the promotions page and is subject to change
- 4. The minimum deposit to qualify for receiving the welcome bonus is \$100
- 5. The notional value of the bonus is credited to the MT4 account balance once the trading requirements have been met.
- 6. Once the trading requirements have been met, clients must claim real the Welcome Bonus. The volumes will be calculated and verified prior to crediting
- 7. The crediting of any bonus amount will be final
- 8. Trading requirements: For every \$1 bonus claimed the client must complete the lot requirement of 0.3 lots (100,000 units of currency open and closed [buy or sell]) Example: Deposit \$1,000, bonus 50% = \$500 \* 0.3 = 150 lots

## **Rebate Programs**

- 1. The Rebate program is available to all clients
- 2. The Rebate program offers specific rebate rates for trading on specific accounts
- 3. The minimum qualifying deposit requirement is set out on the promotion page and is subject to change
- 4. The minimum trade volume requirement for each program is set out on the promotion page and is subject to change
- 5. Rebate rates are paid are according to the account type
- 6. Instant Rebate crediting is subject to availability
- 7. Instant rebates are credited to a separate MT4 account as cash
- 8. Prior to trading, clients must contact the support team for the set up of instant rebates, any volumes traded before the set up on the instant rebate account shall not qualify for rebates
- 9. Continuation in the rebate program is subject to maintaining the minimum balances set out on the promotions page and are subject to change

## Free VPS (Virtual Private Server)

- 1. The free VPS is available on all account types

- 9. The Company is not responsible to monitor the VPS functionality nor the settings implemented within the VPS.
- 10. It is recommend that the client checks the auto-update settings from within the VPS to ensure that trading is not disturbed
- 11. Volumes are calculated on a monthly basis
- 12. Zero profit positions will not qualify for this offer
- 13. General promotion terms and conditions apply.

## **No Deposit Bonus**

- 1. The No Deposit Bonus is available a the Classic or Scalper account only
- 2. The offer is available to new clients who have not previously held an account
- The offer is available to clients that have not previously received a No Deposit Bonus to any account
- 4. The No Deposit Bonus will be added only to verified live accounts
- 5. The No Deposit Bonus is available for 14 days
- 6. The sum of the No Deposit Bonus credited cannot be withdrawn
- 7. Profits generated from the No Deposit Bonus can be withdrawn
